Group 3 fully supports CMP's objection. Groups 2 & 10's argument cannot be taken seriously given that it flouted the rules in an attempt to file the testimony of LUPC-only witnesses to rebut DEP issues. Moreover, CMP's objection was precipitated by a series of misfires by Groups 2 & 10 the most significant of which was not following clear instructions to label testimony. Group 3 has found it difficult to prepare cross-examination for Groups 2 & 10 because it is not clear who is testifying at which proceeding. For example, Group 2 contains one member who is a DEP-only intervenor and several members who are intervenors at the DEP and LUPC. Other than Ms. Caruso (on behalf of the Town of Caratunk), it is impossible to know if Group 2's witnesses are testifying to DEP or LUPC issues because the testimony is not labelled and it is unclear if the testimony is on behalf of a member in both proceedings or the member in only the DEP proceeding.
